

PRIZE FEE RETURNED 100%

TOURNAMENT RULES

- Each bowler must have a membership card from Heart City USBC, either by having paid their original membership fee or a multi-membership fee.
- Bowlers bowling in Heart City USBC but sanctioned in an association outside Heart City USBC must pay a \$5.00 local fee prior to bowling in the tournament.
- **Heart City USBC** averages will be used: (A) Highest final yearbook certified average of the 2017-2018 season (21 games or more); (B) Current average as of February 23, 2019 (21 games or more); and (C) If no average is available 200 will be used.
 - Handicap will be 100% of 200.
 - Bowlers may bowl on more than one team or doubles, but the first score will count for All-Events.
 - No more than two (2) members of one team may participate more than once on the same team
- *An individual may enter:* (A) *doubles multiple times as long as it is not with the same partner*
(B) *singles only once*
(C) *if you bowl doubles or singles, you must bowl both*
- No change in order of line-up, except for substitutions.
- Substitutes are NOT required to reimburse the entry fee paid by the original entrant and are entitled to all prize winnings, including awards. Substitutes to be eligible for All-Events must replace the same bowler in Team, Doubles and Singles. **No Pacers allowed.**
- *Senior Singles Handicap and Senior All-Events Handicap* are optional to persons 50 and over with a separate prize list. Winners will be based on handicap scores. Payment must be included with entry form.
- Choice of dates will be given when possible as the Tournament Director receives entries. The tournament will be extended if necessary.
- **Tournament Bowling will start promptly at the scheduled times. Tardy bowlers will receive “0” for all frames missed.** USBC Rule 322a applies. Tardy bowlers will receive credit only for frames bowled.
- All bowlers must check in 30 minutes prior to scheduled squad time. Lane assignments will be determined by the computer. NO CHANGES. No exceptions. After the schedule is printed, if you find it necessary to change your bowl date or time, it is your responsibility to find a Team/D/S to switch. Notification of such a change must be in the hands of the Tournament Director 24 hours prior to earliest squad time involved.
- *All prize money will be returned 100%.* Prizes will be awarded to Handicap Team, Doubles, and Singles. In case of a tie Co-Champions will be declared. The eligibility of persons winning prizes will be checked. If you are unable to collect prize money at the city banquet, contact Jane Culp at 574-262-1624.
- Official recorders will be assigned to lanes. No one is allowed in the bowling area except bowlers, recorders, and tournament officials.
